A graduate of Brooklyn Law School in 1998 (where he won the CALI Excellence for the Future Award for achieving the highest grade in Food & Drug Law course) and Pittsburgh's Duquesne University (cum laude) in 1995, Kalman was a Judicial Law Clerk for the Superior Court of New Jersey from 1998 to 1999, and engaged in private practice for two prominent New Jersey/New York-based law firms from 1999 to 2007, representing a diverse variety of companies, including Fortune 500 companies.

He relocated to Toronto in 2007 when he became Assistant General Counsel for lovate Health Sciences, creator of some of the most iconic supplement brands in the world, such as Hydroxycut and Muscle Tech. He re-entered private practice in 2011 when he formed his solo practice which would eventually become Magyar, Bogle & O'Hara LLP.
